

In compliance with the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act, 20 USC 1092(F) of 1990, Grand View University prepares and distributes its Annual Campus Security Report. This report includes statistics for the previous three calendar years concerning reported crimes that occurred on campus; in certain off-campus building or property owned or controlled by Grand View University; and on public property within, or immediately adjacent to and accessible from the campus. The report also includes institutional policies concerning campus security, such as policies concerning alcohol and drug use, crime prevention, the reporting of crimes, sexual assault and other matters. It should be noted that many crimes go unreported or unnoticed. Crime reports are recorded if official reports are filed and there is reason to believe they are valid. Reports do not suggest conviction, arrests, etc. The crime statistics reported for the last three calendar years reflect those that were reported to the Vice President for Student Affairs and campus security. It is important to note that if a crime was not reported, it will not be reflected in the recorded statistics.
