

## Chapter 1606: Montgomery GI Bill®- Selected Reserve

### How to apply for and use Chapter 1606 GI Bill® benefits at Grand View University (GV)

1. **Apply and be accepted to GV**
2. **Provide to GV School Certifying Official (SCO)**
  - Visit [http://www.benefits.va.gov/gibill/get\\_started.asp](http://www.benefits.va.gov/gibill/get_started.asp) to apply for benefits, if not already completed
  - Your Certificate of Eligibility or a screenshot of your eBenefits page showing VA education benefit approval
  - MGIB Kicker Contract (Kicker Addendum)
  - **If you've used your benefits at another college or university**, complete a Request for Change of Program or Place of Training (VA Form 22-1995) online and provide evidence of completion to GV SCO <https://www.vets.gov/education/apply/>
3. **Request your JST Transcript be shared with GV-** <https://jst.doded.mil/smart/signIn.do>
4. Work with an academic advisor to **register for courses** – inform the SCO once registered
5. **Notify SCO if you change to GoArmyEd Federal Tuition Assistance benefits because Fed TA and 1606 cannot be used for the same classes.**
6. **You must verify your enrollment each month to VA** through WAVE ([www.gibill.va.gov](http://www.gibill.va.gov)) or call 877-823-2378

### How Chapter 1606 GI Bill® benefits work

GV SCO will submit your enrollment about a month prior to the start of the semester in Fall and Spring terms (Fall and Spring are automatically certified after receipt of Certificate of Eligibility; Summer terms require annual student certification request). **Schedule changes may impact your entitlement amount, creating a VA debt you will be responsible to repay.** You will receive funds based on your enrollment status for each term. VA standards for enrollment status may vary from GV standards. The VA prorates payments for partial months of school. Verify your enrollment each month to VA.

**You are responsible for paying Grand View.** Please contact Student Accounts if you need to set up a payment plan.

Rates effective 10/1/2023:

Full time = \$466.00 per month (+ kicker if eligible)  
 ¾ time = \$349.00 per month (+ kicker if eligible)  
 ½ time = \$233.00 per month (+ kicker if eligible)  
 ¼ time = \$116.50 per month (+ kicker if eligible)

The entitlement is up to 36 months of full-time use, good for 14 years from your beginning date of eligibility or on the day you leave the Selected Reserve. Can be combined with other programs for up to 48 months of eligibility.
