



# Paralegal – Business and Human Resource Management

DMACC Degree Awarded: Associate in Applied Science Grand View Degree Awarded: Bachelor of Arts

This completion plan is designed for students pursuing an AAS in Paralegal at DMACC and planning to transfer to Grand View to earn a BA in Paralegal Studies – Business and HR Management concentration. GV Core Seminars, Composition, and Quantitative Reasoning requirements are included on this plan, but students must fill in the remaining Core Curriculum requirements, any additional major and/or minor requirements, and electives and upper division courses.

To earn a Paralegal AAS degree at DMACC, a student must complete 64 credits, the AAS Core, the paralegal courses, maintain a 2.0 grade point average, and earn a grade of C or higher in each PRL course. Students must complete a minimum of 12 semester credit hours of legal specialty (PRL) coursework at DMACC in a format where all required seat time is delivered face-to-face.

All GV students must complete the GV Core, earn 124 credits, with 30 upper division credits and the last 30 credits at Grand View in order to graduate. Major courses taken at GV will be counted in computing the 2.2 major GPA required for this major.
