## International Off-Campus Study Insurance Options

- You are required to have adequate health insurance coverage while abroad. The types of coverage required are 1) repatriation, 2) evacuation, and 3) health care coverage for international locations. Additional coverage recommended includes 1) property, 2) cancellation, and 3) tuition.
- We suggest you purchase the International Student Identity Card (ISIC). The ISIC provides repatriation and evacuation coverage but does not provide adequate health care coverage. Some programs have health insurance coverage as part of the program fee. For clarification, see your program coordinator.
- Please note Study Tour participants are required to purchase the plan provided through Grand View. If you find that you need to purchase health insurance for your International Travel and/or Off-Campus Study Program, you are free to purchase any policy of your choosing.
- If you are already covered for locations outside of the United States through an existing policy, please provide information on that coverage in the Health Insurance Information Form.
