WHAT YOU SHOULD DO:

(Enrollment history is available on your student record at www.nslsds.ed.gov). If you have already submitted transcripts for all institutions to the Registrar at Grand View University, you do not need to resubmit.
- Complete a typed statement for each school you received Federal Pell Grant or Direct Loan funds during the review period for which you did not earn academic credit.
- Attach third-party documentation to support your statement.

Submit the completed, signed worksheet, transcripts, and typed statement(s) with supporting documentation if you did not earn academic credit during any period to your financial aid administrator.
